### **HOW TO REQUEST COPIES OF JUDICIAL RECORDS**

# THE SWISHER COUNTY & DISTRICT CLERK'S OFFICE WILL NOT PERFORM SEARCHES THAT ARE NOT AUTHORIZED BY STATUTE

Attorney General Opinion WW-607 (1959) the summary states the following: "The County Clerk has no duty to search the records under his control and guarantee the correctness thereof."

  - f. Filing Date
  - g. Disposition Date
  - h. Disposition
  - i. Bondsman Information
  - j. Attorneys on Record
- 2. If you are needing copies, then you will need to proceed with submitting a written request. Written request can be handwritten, typed, or on the Request Form attached.

You may submit your request 1 of 3 ways:

- 3. All request will be reviewed and responded to within 10 days from the initial request.
- 4. Once your request is received, you will be notified of the cost associated with the request.
- 5. Copies will be provided once payment has been received.
